


Shepton Mallet Aims & Objectives Community Engagement Report January 2019

Background

Shepton Mallet began their Neighbourhood Plan in 2014 with Mendip District Council designating the neighbourhood plan area as the whole of the Shepton Mallet Parish area on the 10th February of that year. The plan period will run from 2016 to 2029.

A total of 186 people completed the survey, representing 1.79% of the population.

It can be seen that the age range of respondents does not fully reflect the age range in the community. This is very usual with a survey of this type and provides useful information to allow the steering group to identify age groups which need targeting in the future.


Method

The steering group have been working since 2014 on creating a vision and objectives that reflect the requirements of Shepton Mallet community. This has involved drop-in events, stalls at local events and pop-up stands etc. From this work, a questionnaire was designed, centred around the aims objectives identified. The questionnaire was divided into sections according to subject, to reflect the topics addressed in the Neighbourhood Plan to date. Respondents were asked to agree, disagree or comment on the Aims for Shepton Mallet and then asked to strongly agree/disagree or strongly disagree with the objectives.

Results

Aim 1-Housing and the Built Environment:


"To support the future growth, whilst retaining the distinctive historic character of the town, together with maintaining the rural setting and views"

23	Agree, providing amenities and facilities are developed alongside new housing


Objectives 1-Housing and built Environment Objectives



For local residents, providing enough parking in new developments proved of great importance with 84% of respondents strongly agreeing with the objective. This was followed by 68% of residents strongly agreeing that housing of high-quality design that provides for younger families and local people is of great importance.

Aim 2-Transport


To ensure that future growth mitigates for the increased traffic and vehicle usage by making provision for this within development design



Transport is a very important issue to residents, with 45% of respondents taking the opportunity to comment on it in question 9. The transport aim also raised the most comments relating directly to that. 78% of respondents strongly agreed that transport links and public rights of way should be improved.




Objective 3-Town Centre and Economy

Aim 4-Health, Recreation and Community


